

SATISFACTION OF DEED OF TRUST/MORTGAGE

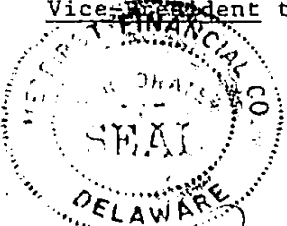

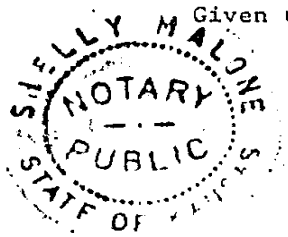
