ORDINANCE NO. 884

AN ORDINANCE ANNEXING CERTAIN PROPERTY TO THE VILLAGE
OF FLOSSMOOR, COOK COUNTY, ILLINOIS

(44.15 Acres)

WHEREAS, the territory described in Exhibit A, attached hereto and made part hereof, is a territory which is unincorporated territory; is less than 60 acres, is wholly bounded by the Village of Flossmoor, the Village of Olympia Fields and the Cook County Forest Preserve; and

WHEREAS, the Corporate Authorities of the Village of Flossmoor have caused notice, stating that annexation of the territory described in Exhibit A is contemplated pursuant to Illinois Revised Statutes, Chapter 24, Section 7-1-13, to be published in the Southtown Economist, that being a newspaper of general circulation within the territory, on October 7, 1988, said date being not less than ten (10) days before the passage of this Ordinance.

WHEREAS, legal notices regarding the intention of the Village to annex said territory have been sent to all public bodies required to receive such notice by State statute; and

WHEREAS, affidavits of such notice required to be recorded, if any, shall be recorded in the Office of the Recorder of Deeds of Cook County; and

WHEREAS, all documents and other necessary legal requirements are in full compliance with the statutes of the State of Illinois, specifically Chapter 24, Section 7-1-13, Illinois Revised Statutes; and

WHEREAS, it is in the best interests of the Village of Flossmoor that said territory be annexed thereto.

NOW, THEREFORE, BE IT ORDAINED by the Mayor (President) and Board of Trustees of the Village of Flossmoor, Cook County, Illinois, as follows:

EXHIBIT A

That part of the West Half (½) of the Southwest Quarter (¼) of Section 11, Township 35 North, Range 13 East of the Third Principal Meridian, bounded and described as follows:
Beginning at the Southwest Corner of the Southwest Quarter (¼) of said Section 11, Thence North on the West Line of the Southwest Quarter (¼) of said Section 11 a Distance of 1654.83 Feet, more or less, to a point on the North Line of the South 20 Acres of the North Half (½) of said Southwest Quarter (¼) of Section 11, Thence East on the last described line to a point 111 Feet West of the East Line of the West Half (½) of said Southwest Quarter (¼) of Section 11, Thence South on a Line 111 Feet West of and Parallel to the East Line of the West Half (½) of said Southwest Quarter (¼) of Section 11 to the North Line of Lot 1 in Wilken's Subdivision of the East Half (½) of the Southeast Quarter (¼) of the Southwest Quarter (¼) of the Southwest Quarter (¼) of said Section 11, Thence West on the last described line of the Northwest Corner of Lot 1 in said Wilken's Subdivision Thence South on the West line of Lot 1, in said Wilken's Subdivision, to the Southwest Corner of Lot 1, in said Wilken's Subdivision also being the Southeast Corner of Lot 2, in said Wilken's Subdivision, Thence West on the South line of Lot 2, in said Wilken's Subdivision, to the Southwest Corner of Lot 2, in said Wilken's Subdivision, also being the Northwest Corner of Lot 3, in said Wilken's Subdivision, Thence south on the West Line of Lot 3, in said Wilken's Subdivision and said line extended South to the South Line of the Southwest Quarter (¼) of said Section 11, Thence West on the South Line of said Southwest Quarter (¼) of Section 11 a distance of 996.30 feet, more or less to the point of beginning all in Cook County, Illinois. Said territory containing 44.15 acres more or less, and being surrounded by the Village of Flossmoor, another municipality and a Forest Preserve District.
