Finally, in order to facilitate the transfer of information between different parts of the brain, parallel pathways are formed by the commissures. The corpus callosum is the largest of these commissures, connecting the two hemispheres. It consists of approximately 200 million fibers, allowing for the simultaneous transmission of information between the left and right hemispheres. Other commissures include the anterior commissure, which connects the optic nerves, and the posterior commissure, which connects the optic tracts.

The brain also contains many internal structures that regulate various physiological processes. The hypothalamus, located at the base of the brain, plays a key role in regulating the body's temperature, hunger, thirst, and sleep-wake cycles. It receives input from various sensory pathways and sends output to the autonomic nervous system, which controls heart rate, blood pressure, and other vital functions. The pituitary gland, located just below the hypothalamus, secretes hormones that regulate growth, metabolism, and reproduction.

The brain is also involved in complex cognitive functions, such as memory, language, and problem-solving. The cerebral cortex, the outer layer of the brain, is divided into four main lobes: the frontal lobe, parietal lobe, temporal lobe, and occipital lobe. Each lobe is responsible for specific cognitive functions. For example, the frontal lobe is involved in executive functions like planning, decision-making, and problem-solving, while the temporal lobe is involved in memory and language processing.

Finally, the brain is a complex organ that requires a constant supply of oxygen and nutrients to function properly. The circulatory system, consisting of the heart and blood vessels, ensures that oxygenated blood reaches all parts of the brain. The brain also contains a network of blood vessels called the meninges, which protect the delicate tissue from damage.
