THIS TRUST DEED, made October 24, 19 88, between Robert Murray and Kathy R. Murray, his wife,

herein referred to as "Mortgagors," and Edward P. Cremerius of Palatine, Cook County, Illinois, herein referred to as TRUSTEE, witnesseth THAT, WHEREAS the Mortgagors are justly indebted to the legal holders of the Promissory Note therein called "Note" hereinafter described, said legal holder or holders being herein referred to as Holders of the Note evidenced by one certain Promissory Note of the Mortgagors of even date herewith, made payable as stated therein and delivered, in and by which said Note the Mortgagors promise to pay an Amount Financed of Twenty-one Thousand Six Hundred Thirty and 33/100 (\$21,630.33) Dollars with interest thereon payable in installments as follows:

Three Hundred Seventy-five and 93/100 (\$375.93) Dollars or more on the 7th day of December 19 88, and Three Hundred Seventy-five and 93/100 (\$375.93) Dollars or more on the same day of each month thereafter until said Agreement is fully paid and except that the final payment, if not sooner paid, shall be due on the 7th day of November, 19 98

NOW, THEREFORE, the Mortgagors to secure the payment of the said sum of money in accordance with the terms, provisions and limitations of this trust deed, and the performance of the covenants and agreements herein contained, by the Mortgagors to be performed, and also in consideration of the sum of One Dollar in hand paid, the receipt whereof is hereby acknowledged, do by these presents CONVEY and WARRANT unto the Trustee, its successors and assigns the following described Real Estate and all of their estate, right, title and interest therein, situate, lying and being in the COUNTY OF Cook AND STATE OF ILLINOIS, to wit:

Lot 1 in Kocaks Resubdivision of Lots 35, 36, 37 and 38 in Stouffers Subdivision of the South 1/2 of the North East 1/4 of Section 6, Township 38 North, Range 12, East of the Third Principal Meridian, (except the East 384.78 feet of the South 417.06 feet thereof) according to the Plat thereof recorded May 31, 1922, as Document 7521572, in Cook County, Illinois.

TOGETHER with all improvements, tenements, easements, fixtures, and appurtenances thereto, including and all rents, issues and profits thereof for so long and during all such times as Mortgagors may be entitled thereto (which are pledged primarily and on a parity with said real estate and not secondarily) and all apparatus, equipment or articles now or hereafter therein or thereon used to supply heat, gas, air conditioning, water, light, power, refrigeration (whether single units or centrally controlled), and ventilation, including (without restriction to the foregoing), screens, window shades, storm doors and windows, floor coverings, awnings, stoves and water heaters. All of the foregoing are declared to be a part of said real estate whether physically attached thereto or not, and it is agreed that all similar apparatus, equipment or articles hereafter placed in the premises by the mortgagors or their successors or assigns shall be considered as constituting part of the real estate.

TO HAVE AND TO HOLD the premises unto the said Trustee, its successors and assigns, forever, for the purposes and upon the uses and trusts herein set forth, free from all rights and benefits under and by virtue of the Homestead Exemption Laws of the State of Illinois, which said rights and benefits the Mortgagors do hereby expressly release and waive.

THIS TRUST DEED MAY NOT BE ASSUMED WITHOUT THE WRITTEN CONSENT OF THE LEGAL HOLDERS OF THE NOTE THAT THIS TRUST DEED SECURES.

This trust deed consists of two pages. The covenants, conditions and provisions appearing on page 2 (the reverse side of this trust deed) are incorporated herein by reference and are a part hereof and shall be binding on the mortgagors, their heirs, successors and assigns.
