ORDINANCE NO. 2917

PLAT WITH THIS DOCUMENT

AN ORDINANCE TO ANNEX CERTAIN TERRITORY  
TO THE VILLAGE OF GLENVIEW, COOK COUNTY,  
ILLINOIS

WHEREAS, pursuant to an annexation agreement executed between the Village of Glenview and Zenith on July 16, 1985, Zenith agreed to annex said property described below to the Village of Glenview.

WHEREAS, the President and Board of Trustees of the Village of Glenview have independently determined that said property described in the aforesaid petition is not within the corporate limits of any municipality, that it is contiguous to the present village limits of the Village of Glenview, and that all property owners, and electors have signed said petition as required by statute.

NOW, THEREFORE, BE IT ORDAINED, by the President and Board of Trustees of the Village of Glenview, Cook County, Illinois, that

Section 1: The facts and statements contained in the preamble to this ordinance are found to be true and correct and are hereby adopted as part of this ordinance.

Section 2: The property commonly known as 1000 Milwaukee Avenue and is legally described as:

(A tract of land in parts of Lots 6 and 7 in the County Clerk's Division of the west 1/2 of the northeast 1/4, part of the east 1/2 of the northwest 1/4 and part of Lot 2 in Dearlove Subdivision in the southwest 1/4, all in Section 32, Township 42 North, Range 12 East of the Third Principal Meridian in Cook County, Illinois, described as follows: Commencing at the intersection of the south line of the northwest 1/4 of said Section 32 and the east line of the Illinois State Toll Highway; thence north 89 58' 33" east along said south line of the northwest 1/4 of said Section 32 for a distance of 100.18' to the point of beginning for the area to be annexed, described as follows: said point of beginning lies on the easterly Corporate Limits line of the Village of Glenview, said Corporate Limit line is 100.00 feet east of and parallel to the easterly line of aforementioned Illinois State Toll Highway; thence north 89 58' 33" east along the aforementioned south line of the northwest 1/4 of section 32, for a distance of 638.61 feet to a point; thence south 86 33' 11" east a distance of 409.57 feet; thence north 8 26' 49" east a distance of 725.08 feet to a point; thence north 1 49' 31" east a distance of 169.91 feet to a point on a curve; thence northwesterly 417.19 feet along the arc of a circle, convex to the northeast and having a radius of 694.02 feet to a point of tangency; thence north 37 44' 17" west a distance of 48.21 feet; to a point; thence south 52 15' 43" west a distance of 51.18 feet to a point of curvature; thence westerly 293.74 feet along the arc of a circle, convex to the southwest and having a radius of 187.00 feet to a point of tangency; thence north 37 44' 17" west a distance of 187.80 feet to a point; thence north 86 49' 32" west a distance of 419.33 feet to a point of intersection with the easterly Corporate Limits of the Village of Glenview, said Corporate Limits line is 100.00 feet east of and parallel with the easterly line of said

Illinois State Toll Highway;) thence south 3 10' 28" west along the aforementioned easterly Corporate Limit line of the Village of Glenview for a distance 402.53 feet to a point, thence South 3 26' 49" west along the aforementioned Village limits line for a distance of 1066.74 feet to the point of beginning of the area to be annexed, all in Cook County, Illinois.

be and the same is hereby annexed to the Village of Glenview, Cook County, Illinois, pursuant to the provisions of Chapter 24, Section 7-1-8 of the Illinois Municipal Code of 1961, as amended.

Section 3: The Clerk of the Village of Glenview is hereby authorized and directed to record with the Recorder of Deeds of Cook County, Illinois, a certified copy of this ordinance, together with an accurate map of the territory annexed, attached hereto and made a part hereof.

Section 4: Every section and provision of this ordinance shall be separable, and the invalidity of any portion of this ordinance shall not affect the validity of any other portion hereof.

Section 5: This ordinance shall take effect upon its passage, and approval according to law.






