THIS INDENTURE, made this 27th day of October, A.D. 1988 between FIRST NATIONAL BANK OF NORTHBROOK, a national banking association, Northbrook, Illinois, as Trustee under the provisions of a Deed or Deeds in Trust duly recorded and delivered to said bank in pursuance of a trust agreement dated the 16th day of November, 1983, and known as Trust Number 232, Grantor, and WILLIAM M. DAVIS East 8th Street, Apartment 707, Chicago, Illinois, Grantee.

WITNESSETH, that Grantor, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable considerations in hand paid, does hereby convey quitclaim unto Grantee, the following described real estate, situated in Cook County, Illinois, to wit:

SEE EXHIBIT A ATTACHED HERETO AND MADE A PART HEREOF

together with the tenements and appurtenances therunto belong.

SUBJECT TO: (1) general real estate taxes not yet due and payable; (2) special city or county taxes or assessments for improvements not yet completed; (3) easements, covenants, restrictions and building lines of record; (4) encroachments if any; (5) applicable zoning and building laws or ordinances; (6) acts done or suffered by, through or under Grantee; (7) the Condominium Property Act of the State of Illinois (the "Act"); (8) the Declaration of Condominium Ownership and of Easements, Restrictions, Covenants and By-Laws for Woods Edge III Condominium and all amendments thereto (the "Declaration"); (9) Declaration of Covenants, Conditions, Restrictions and Easements for Woods Edge Homeowner's Association and all amendments thereto (the "Homeowners' Declaration"); (10) liens and other matters over which the title insurer provided for herein commits to insure by endorsement; and (11) existing leases, licenses and agreements affecting the Common Elements.

Grantor also hereby grants to the Grantee, its successors and assigns, as rights and easements appurtenant to the above-described real estate, the rights and easements for the benefit of said property set forth in the Declaration of Condominium, as aforesaid, and in the Declaration of Covenants, Conditions, Restrictions, and Easements recorded as Document No. 23667054, as supplemented by instrument recorded as Document No. 25462662 and Grantor reserves to itself, its successors and assigns, the right and easements set forth in said Declaration for the benefit of the remaining property described therein.

This Deed is subject to all rights, easements, covenants, conditions, restrictions and reservations contained in said Declarations the same as though the provisions of said Declarations were recited and stipulated at length herein.

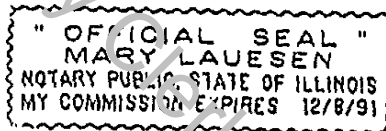
