ASSIGNMENT AND ASSUMPTION OF LEASE

THIS ASSIGNMENT AND ASSUMPTION OF LEASE (the "Assignment") is made and entered into as of the Bull day of November, 1988, by and between FINE ARTS THEATRES INC., an Illinois corporation ("Assignor"), and LOEWS CHICAGO CINEMAS, INC., an Illinois corporation ('Assignee").

- 2. Assumption of Tenant's Obligations. Assignee hereby covenants and agrees to assume, be bound by and perform all of

the terms, covenants, agreements, conditions and provisions of the Lease on the part of Assignor to be honored, observed and/or performed with respect to facts or events occurring after the date hereof.
