WAIVER OF RIGHTS TO FILE MECHANIC'S LIENS

This Agreement, made and entered into this 27th day of October ______, 19<u>88</u>, by and between Illinois Bell Telephone Company, an Illinois corporation, with offices at 225 West Randolph Street, Chicago, Illinois, 60606 (hereinafter called the "Owner") and Grand-Kahn Electric, Inc., an Illinois Corporation with offices at 1339 S. NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.20) and other good and valuable consideration, receipt of which is hereby acknowledged by Contractor, Contractor does now hereby fully and completely waive and release, for Contractor and Contractor's heirs, successors and assignees, and fr. at Contractor's subcontractors and their respective subcontractors, any and all claims of, or right to mechanic's liens under the provisions of a certain act of the State of Illinois entitled, "An Act to Revise the Law in Relation to Mechanic's Latt." approved May 18, 1903, and in force July 1, 1903, as amended from time to time thereafter, against, or with respect to time above described premises, or any portion thereof, or any improvements thereon, or with respect to the estate or interest of any person whatsoever in 🔒 the said premises or improvements, or any portion thereof, or with respect to any material, fixtures, apparatus and ... machinery to be furnished to the said premises or with respect to any monies or other considerations which may are be due at any time hereafter from Owner to Contractor, which claim of lien might be asserted by rea or of the doing, making or finishing heretofore or at any time hereafter, by Contractor or Contractor's heirs, successors, assignees, materialmen, subcontractors or sub-subcontractors, of any labor, services, material, fixtures, apparates, machinery, improvements, repairs or alterations in connection with the above described premises or the improvements therein. It is expressly agreed that the effect of this Wniver shall not be impaired, affected or diminished by any provision of the Contract relating to the production from time to time, of written waivers of liens, or by any other provision(s) contained therein apparently inconsistent with this Waiver.
