PARTIAL RELEASE OF PURCHASE MONEY MORTGAGE AND SECURITY AGREEMENT

TO HAVE AND TO HOLD the same, with all appurtenances thereto, unto the said Mortgagor, its successors, and assigns forever, freed, exonerated and discharged of and from the lien of the Mortgage, and every part thereof; provided, however, that nothing herein contained shall in anyway impair, alter or diminish the effect, lien or encumbrance of the aforesaid Mortgage on the remaining part of the Mortgaged Premises not hereby released therefrom, or any of the rights and remedies of the holder thereof.




