to the premises situated in the County of Cook, State of Illinois, described as follows, to-wit:

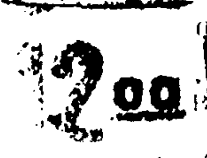

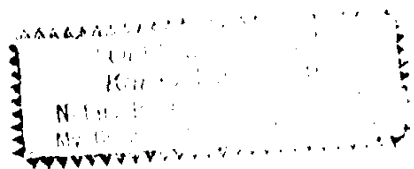
