## ERSE SIDE OF THIS MORTGAGE AND INCORPORATED THEREIN BY REFERENCE

- 1. Mortgagors shall (1) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed: (2) keep said premises in good condition and repair, without waste, and free from mechanic's or other liens or claims for lien not expressly subordinated to the lien beteof. (3) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien bereof and upon request exhibit satisfactory evidence of the discharge of r. (in prior lien to Mortgagee or to holder of the contract. (4) complete within a reasonable time any building or buildings now or at any time in process of erection upon said premises. (5) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof. (6) make no material alterations in said premises except as required by law or municipal ordinance. or muntcipal ordinance.
- 2. Mortgagors shall pay before any penalty attaches all general taxes and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall upon written request, furnish to Mortgagee or to holders of the contract duplicate receipts therefor. To prevent default hereunder Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagors may desire to contest.
- 3. Mortgagors shall keep all buildings and improvements now and hereafter situated on said premises insured against loss or damage by fire. 3. Mortgagors shall keep all buildings and improvements now and bereatter situated on said premises insured against loss of damage by tree. lightning and windstorm under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured hereby, all in companies satisfactory to the holders of the contract, under insurance policies payable, in case of loss or damage to Mortgages, such rights to be evidenced by the standard mortgage clause to be attached to each policy, and shall deliver all publicles including additional and renewal policies to holder of the contract and in case of insufance about to expire, shall deliver at policies not less than ten days prior to the respective dates of expiration.
- 4. In case of default there'n, Mortgagee or the holder of the contract may, but need not, make any payment or perform any act hereinbefore required of Mortgagors in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discharge, compromise or settle any tax lien or other prior lien or tille or elain thereof, or redeem from any tax sale or forfeiture, affective said premises or contest any tax or assessment. All moneys paid for any of these purposes herein authorized and all expenses paid or incure d, ne connection therewith, including strongeys fees, and any other moneys advanced by Mortgagee or the holders of the contract to protect the low rigaged premises and the lien hereof, shall be so much additional indebtedness secured hereby and shall become immediately due and payable without notice. Inaction of Mortgagee or holders of the contract shall never be considered as a waiver of any right payments to their one terminates. accraing to them on account at any default hereunder on the part of the Mortgagors
- 5. The Mortgager or the hoofer of the contract hereby secured making any payment hereby authorized relating to taxes and assessments, may do so according to any bill, statemer constituate procured from the appropriate public office without inquiry into the accuracy of such bill, statement or estimate or into the validity of any consessment, sale, forfeiture, tax lien or title or claim thereof.
