THIS INDENTURE, made November 8th, 1988, between James Hawthorne and

Corine Hawthorne, His Wife, As Joint Tenants . . . . . A Delaware corporation, herein referred to as "Mortgagors," and Security Pacific Financial Services, Inc., a California corporation, herein referred to as TRUSTEE, witnesseth:

TO HAVE AND TO HOLD the premises unto the said Trustee, its successors and assigns, forever, for the purpose, and upon the uses and trusts herein set forth, free from all rights and benefits under and by virtue of the Homestead Exemption Laws of the State of Illinois, which said rights and benefits the Mortgagors do hereby expressly release and waive.
