Accrued interest and costs to date are due and payable on 2nd day of December, 1980 and on the 2nd day of each month thereafter; and the principal sub, accrued interst and costs advanced hereunder and if not sooner paid, shall be due on the 12th day of May, 1989 said Note bears interest at an annual rate equal to 11%; any installments not paid promptly when due bear interest at an annual rate equal to the Index rate plus 5%.

TOGETHER with all right, title, estate and interest of the First Party in and to the Premises, estate, property, improvements, furniture, furnishings, apparatus and fixtures hereby conveyed, and igned, pledged and hypothecated, or intended so to be, and all right to retain possession of the Premises after event of default in payment, or breach of any covenant herein contained; and

TOGETHER with all awards and other compensation heretofore or hereafter to be made to the present and all subsequent owners of the Premises for any taking by eminent domain, either permanent or temporary, of all or any part of the Premises or any easement or appurtenance thereof, including severance and consequential damage and change in grade of streets, which said swords and compensation are hereby assigned to Trustee, and First Party hereby appoints. Trustee its attorney-in-fact, coupled with an interest, and authorizes, directs and empowers such attorney, at the option of the attorney, on behalf of First Party, or the successors or assigns of First Party, to adjust or compromise the claim for any award and to collect and receive the proceeds thereof, to give proper receipts and acquittances therefor, and, after deducting expenses of collection, to apply the net proceeds as a credit upon any portion, as selected by Trustee, of the Indebtedness Hereby Secured, notwithstanding the fact that the amount owing

TO HAVE AND TO HOLD the Premises, with the appurlemences, and fixtures, unto the Trustee, its successors and assigns, forever, for the purposes and upon the assessed purposes herein set forth together with all right to possession of the Premises upon the accurrence of any Event of Default as herrinafter defined; the First Party hereby HELEASING and WAIVING all rights under and by virtue of the homestead exemption laws of the State of Illinois.

PROVIDED. NEVERTHELESS. that if the First Party shall pay when due the Indebtedness Hereby Secured and shall duty and timely perform and observe all of the terms, provisions, covenants and spreements herein provided to be performed and observed by the First Party, then this Trust Deed and the estate, right and interest of the Trustee in the Premises shall cease and become void and of no effect, otherwise to remain in full force and effect.

THE FIRST PARTY COVENANTS AND ACREES AS FOLLOWS:

- 1. <u>Phyment of indebtedness</u>: The First Party shall pay when due (a) the principal of and interest and premium, if any on the indebtedness evidenced by the Note and (b) all other indebtedness Hereby Secured: and the First Party shall duly and punctually perform and observe all of the terms, provisions, conditions, covenants and agreements on the First Party's part to to performed or observed as provided because and in the Note; and this Trust Deed shall secure such payment, performance and observance.
- 2. Maintenance. Repair. Restoration. Liens. Etc.: Pursuant to and subject to the terms of the Construction Loan Agreement the First Porty shall is) promptly repair, restore or rebuild any building or improvement now or hereafter on the formises which may become darayed or be destroyed whether or act proceeds of insurance are available of ufficient for the purposes; (b) keep the Premises in good condition and repair, without waste, and free from mechanic's, materialmen's or like liens or claims or other liens or claims for lien; (c) pay, whin due, any indebtedness which may be secured by a lien or charge of the Premises superior to the lien hereof and, upon request, exhibit to the Trustee satisfactory evidence of the discharge of such prior lien, (d) complete the construction of any improvements within a reasonable time, now or at any time in the process of repair or erection upon the Premises; (e) comply with all requirements of law, municipal ordinances or restrictions and covenants of record with respect to the Premises and the use thereof (f) make or permit no material alterations in the Premise except as required by law or ordinance without the prior written consent of the Trustee; (g) suffer or permit no change in the general nature of the occupancy of the Premises; (h, initiate or acquiesce in no zoning reclassification with respect to the Premises; and (i) suffer or perm. In unlawful use of, or nuisance to exist upon the Premises.
- 3. Other Liens: The First Party shall not create or suffer or permit any mirlyage. Lien. charge or encumbrance to attach to the Premises, whether such lien, charge or encumbrance is inferior or superior to the lien of this Trust Deed, excepting only the lien of real estate texes and arse sevents not due or delinquent.
- A. Taxes: The First Party shall pay before any penalty attaches, all general and special taxes, assessments, water charges, sewer charges, and other fees, taxes, charges and assessments of every kind and nature whatsoever (all herein generally called 'Taxes'), whether or not assessed against the First Party, if applicable to the Premises or any obligation or agreement secured hereby; and First Party shall, upon written request furnish to the Trustee duplicate receipts therefor. The First Party shall pay in full under protest in the manner provided by statute, any Taxes which the First Party may desire to contest: provided, however, that if deferment of payment of any such Taxes is required to conduct any contest or review, the First Party shall deposit with the Trustee the full amount thereof, together with an amount equal to the estimated interest and penalties thereon during the period of contest, and in any event, shall pay such Taxes notwithstanding such contest, if in the opinion of the Trustee the Premises shall be in jeopardy or in danger of being forfeited or foreclosed; and if the First Party shall not pay the same when required so to do, the Trustee may do so and may apply such deposit for the purpose. In

the event that any to of court decise has the iffect of the court water and for the purpose of taxation any lien thereon, or imposing upon the Trustee the payment of the whole or any part of the Taxas or liens herein required to be paid by the First Party, or changing in any way the laws relating to the taxation of mortgages or debta secured by mortgages or the interest of the Trustee in the Premises, or the manner of collection of Taxas, so as to adversally effect this Trust Daed or Indebtedness Hereby Secured or the Trustee, then, and in any such event, the First Party, upon demand by the Trustee, shall pay such Taxas, or reimburse the Trustee therefor on demand, unless such payment or reimbursement by First Party is unlawful in which event the Indebtedness Hereby Secured shall be due and payable within thirty (30) days after written demand by Trustee to First Party. Nothing in this Paragraph 4 contained shall require the First Party to pay any income, franchise or excise tax imposed upon the Trustee, excepting only such which may be levied against such income expressly as and for a specific substitute for Taxas on the Premises, and then only in an amount computed as 11 the Trustee derived no income from any source other than its interest hereunder.

- 5. Insurance Coverage: The First Party will insure or cause to be insured and keep or cause to be kept insured all of the buildings and improvements now or hereafter constructed or erected upon the fremixes and earn and every part and parcel thereof, against such perits and hazards as the Trustee may from time to time require under the terms of the Construction Loan Agreement.
- 6. Proceeds of incurance: The First Party will give the Trustee prompt notice of any damage to or destruction of the Premiser, and:
 - [a] In case of loss toward by policies of insurance, the Trustee (or. after entry of decree of foreclosure, the purchaser at the foreclosure sole of decree creditor, as the case may be) is hereby authorized at its option either (i) to settle and adjust any claim under such policies without the consent of the first party, or ii, allow the First Party to agree with the insurance company or companies on the amount to be paid upor for loss; and provided that in any case the Trustee shall, and is hereby authorized to, collect and receipt for any such insurance proceeds; and the expenses incurred by the Trustee in the adjustment and collection of insurance proceeds shall be so much additional indebtedness Hereby Secured, and shall be reimburred to the Trustee upon demand.
 - [b] In the event of any insured damage to or destruction of the Premises or any part thereof [herein called an "Insured Cakualty"], and if, in the repronable judgment of the Trustee, the Premises can be restored to an economic unit not less valuable than the same was prior to the Insured Casualty and adequately securing the outstanding balance of the Indeltedness Mereby Secured, then, if no Event of Default, as hereinafter defined, shall have occurred and be then continuing, the proceeds of insurance shall be applied to reimburse the First Party for the cost of restoring, repairing, replacing or rebuilding the Premises of part thereof, as provided for in Paragraph 3 hereof; and the First Party hereby covenants and agrees forthwith to commence and diligently to prosecute such restoring, replacing, replacing, replacing, replacing, replacing, replacing or rebuilding in excess of the net proceeds of insurance made available pursuant to the terms hereof.
 - (c) Except as provided in Subsection (b) of this Paragraph 6, the Truster may apply the proceeds of insurance consequent upon any insured Casualty upon the indebtedness Hereby Secured, in such order or manner as the Trustee may elect.
 - (d) In the event that proceeds of insurance, if any, shall be and available to the First Party for the restoring, repairing, replacing or rebuilding of the Premises, the First Party hereby covenants to restore, repair, replace or rebuild the same, to be of at least equal value, and of substantially the same character as prior to such damage or destruction, all to be effected in accordance with plans and specifications to be first submitted to and approved by the Trustee.
- 7. <u>Disbursement of Insurance Proceeds:</u> In the event the First Party is entitled to reimbursement out of insurance proceeds held by the Trustee, such proceeds shall be disbursed from time to time upon the Trustee being furnished with astisfactory evidence of the estimated cost of completion of the

Testoration. repair. replacement and rebuilding with funds for assurances assistactory to the Trustee that such funds are evaluable) sufficient in edultion to the proceeds of insurance, to complete the proposed restoration, repair, replacement and rebuilding and with such architect's certificates, waivers of lien, contractor's sworn statements, title insurance endorsements, plats of survey and other such evidences of cost, payment and performance as the Trustee may reseemably require and approve; and the Trustee may, in any event, require that all plans and specifications for such restoration, repair. replacement and rebuilding be submitted to and approved by the Trustee prior to commencement of work. No payment made prior to the final completion of the restoration, repair, replacement and rebuilding shall exceed ninety percent (90%) of the value of the work performed from time to time: funds other than proceeds of insurance shall be disbursed prior to disbursement of such proceeds: and at all times the undishursed balance of such proceeds remaining in the hands of the Trustee, together with funds deposited for that purpose or irrevocably committed to the antiafaction of the Trustee by or on behalf of the First Party for that purpose, shall be at least sufficient, in the reasonable judgment of the Trustee, to pay for the cost of completion of the restoration, repair, replacement or rebuilding, free and clear of all liens or claims for lien. Any surplus which may remain out of insurance proceeds held by the Trustee after payment of such costs of restoration, repair, replacement or rebuilding shall, at the option of the Trustee. be appried on account of the indebtedness Hereby Secured. No interest shall be allowed to the First Party on account of any proceeds of insurance or other funds held in the hands of the Trustee.

- The First Party hereby assigns, transfers and sets over unto the Trustee the ₽, Condemnation: entire proceeds of any award or claim for domnyes for any of the Premises taken or domaged under the power of eminent domain or by condemnation including any payments made in lieu of and/or in settlement of a claim or threat of condemnation. The Trustee may elect to apply the proceeds of the award upon or in reduction of the Indebtedness Hereby Secured then most remotely to be paid, whether due or not, or require the First Party to restore of cobuild the Premises. in which event, the proceeds shall be held by the Trustee and used to reimburse the Farst Party for the cost of such rebuilding or restoring. If, in the reasonable judyment of the Trustee, the Premises can be restored to an economic unit not less valuable then the same was prior to the condimention and adequately securing the outstanding balance of the Indebtedness Rereby Secured, the award shall be used to reimburse the First Party for the cost of restoration and rebuilding: provided always. (b) no Event of Default has occurred and is then continuing. If the First Party is required or permitted to rebuild or restore the Premises as aforesaid. such rebuilding or restoration shall be effected solely in accordance with plans and specifications previously submitted to and approved by the Trustee, and proceeds of the award shall be paid out in the same manner as is provided in Paragraph 9 hereof for the parment of insurance proceeds towards the cost of rebuilding or restoration. If the amount of such award is insufficient to cover the cost of rebuilding or restoration, the First Party shall pay such could be excess of the award, before being entitled to reimburgement out of the sward. Any surplus which may remain out of the sward after payment of such costs of rebuilding or restoration shall, at the option of the Triplee, be applied on account of the Indebtedness Hereby Secured. No interest shall be allowed to First Party on account of any award held by Trustee.
- 2. The Stamp: If, by the laws of the United States of America, or of any state or municipality having jurisdiction over the First Party or the Premises, any tax becomes due in respect of the issuance of the Note or this mortgage, the First Party shall pay such tax in the manner required by law.
- Indebtedness Hereby Secured, or any part thereof, be extended or varied, or if any part of the security therefor be released, all persons now or at any time hereafter liable therefor, or interested in the Premises, shall be held to assent to such extension, variation or release, and their liability, and the lien and all provisions hereof, shall continue in full force and effect: the right of recourse against all such persons being expressly reserved by the Trustee, notwithstanding any such extension, variation or release. Any person, firm or corporation taking a junior mortgage or other lien, upon the Premises or any interest therein, shall take the said lien subject to the rights of the Trustee to smend, modify and supplement this Trust Deed, the Note and the Assignments herein referred to, and to extend the maturity of the Indebtedness Hereby Secured, in each and every case without obtaining the consent of the holder of such junior lien and without the lien of this Trust Deed losing its priority over the rights of any such

- Truster's Performance of Piret Party's Obligations: In case of an Event of Default herein, the Truster, either before or after acceleration of the Indebtadness Mereby Securad of the foreclosure of the lien hereof and during the period of redemption, if any, may but shall not be required to, make any payment or perform any act herein required of the First Party (whether or not the First Party is personally liable therefor) in any form and manner dermed expedient to the Trustee; and the Trustee may. but shall not be required to, make full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discharge, compromise or settle any tax lien or other prior lien or title or claim thereof, or redeem from any tax note or forfaiture affecting the Premises or contest any tax or assessment, and may, but shall not be required to, complete construction. Inaction of the Trustee shall never be considered as a waiver of any right occruing to it on account of any default on the part of the First Party. The Trustee in making any payment hereby authorized (a) relating to taxes and assessments, may do so according to any bill, statement to, estimate, without inquiry into the validity of any tax. assessment, sale, forfeiture, tax lien of title or claim thereof: (b) for the purchase, discharge. compromise or settlement of any other prior lien, may do so without inquiry as to the validity or amount of any claim for lien which may be asserted: and (c) in connection with the completion of construction. furnishing or equipping of the improvements of the free ises or the rentsi, operation or management of the Premises or the payment of operating costs and expense, thereof. Truster may do so in such amounts and to such persons as Trustee may deem appropriate and may only into such contracts therefor as Trustee may deem oppropriate or may perform the same itself.
- 12. Financial Statements: First Party covenants and agrees while any Indebtedness Hereby Secured Is obtaining, to furnish to the holder of the Note within minety (50) days at the end of each fiscal year of its operation, an annual financial statement showing the operation of the Premises and of First Party, and financial statements being prepared and reviewed by an independent critical public accountant. The financial statements required under the provisions of this paragraph shall include the financial data relevant to the operation and ownership of the real estate and, in the event the improvements thereof are operated by a lessee, statements required shall include an audit of the operations of the lessee, which shall also be provided within minety days of the end of the fiscal year of the lessee. Each of such financial statements shall be comprehensive and reflect, in addition to other data, the following: gross income and source, real estate taxes, insurance, operating expenses in reasonable detail, depreciation deduction for federal income tax purposes, federal income taxes and net income. Within thirty (30) days of filing. First Party shall furnish to the holder of the Note copies of federal and state income taxes filed.
- 13. Restrictions on Transfer: It shall be an Event of Default bereunder if, without the prior written consent of the Trustee any one or more of the following shall occur:
 - (a) If the First Party shall create, effect or consent to or shall suffer or permit any conveyance, sale, assignment, transfer, lien, pledge, mortgage, security interest or other encumbrance or slicenation of the Premises or any part thereof or interest therein, excepting only sales or other dispositions of Collateral (herein called "Obsolete Collateral") no longer useful in connection with the operation of the Premises, provided that prior to the sale or other disposition thereof, such Obsolete Collateral has been replaced by Collateral, subject to the first and prior lien hereof, of at

least equal value and utility:

- (b) If the First Party is a Land Trustee, then, if any beneficiary of the First Party shall create, effect or consent to, or shall suffer or permit any sale, assignment, transfer, lien, pledge, mortgage, accurity interest or other encumbrance or alienation of all or any portion of such beneficiary's beneficial interest in the First Party:
- (c) If the First Party is a partnership or joint venture, or if any beneficiary of a trustee mortgager in a partnership or joint venture, then if any General Partner or joint venturer in such partnership or joint wenture shall create, effect or consent to or shall suffer or permit any sale. assignment. transfer, lien, pledge, mortgage, security interest or other sacumbrance or allenation of all or any part of the partnership interest or joint venture interest, as the case may be, of such partner or joint venturer:

 - (e) If (and for the purpose of this Paragraph 19(e) only, the term First Party shall mean and 47 include not only First Party but any beneficiary of a trustee sortgagor, and each person who, as Poguarantor. co-maker or otherwise, shall be or become liable for or obligated upon all or any part of N the Indebtedness Hereby Secured or any of the covenants or agreements contained herein):
