NOTICE OF LIEN

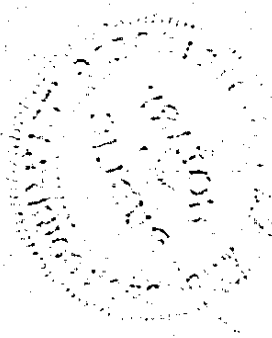
