Nine Hundred Dollars (\$37,900.00), together with costs and disbursements; and the Court having entered an order on August 29, 1988, granting Plaintiffs' Motion for Default Judgment against the Defendant, Advanced Refrigeration Products, Inc., in the amount of Ninety-Seven Thousand Dollars (\$97,000.00), together with costs and disbursements;

NOW THEREFORE, IT IS HEREBY ORDERED that the Defendants, AMA, Inc. and Advanced Refrigeration Products, Inc., as jointly and severally liable, pay to the plaintiffs the above-described damages in the sum of Thirty-Seven Thousand Nine Hundred Dollars (\$37,900.00) and interest thereon at the legal rate for judgments, together with costs and disbursements thereon in the amount of Two Thousand Five Hundred Forty-One Dollars and Sixteen Cents (\$2,541.16).

IT IS HEREBY FURTHER ORDERED, that the Defendant, Advanced Refrigeration Products, Inc., pay to the Plaintiffs the further sum of Fifty-Nine Thousand One Hundred Dollars (\$59,100.00).
