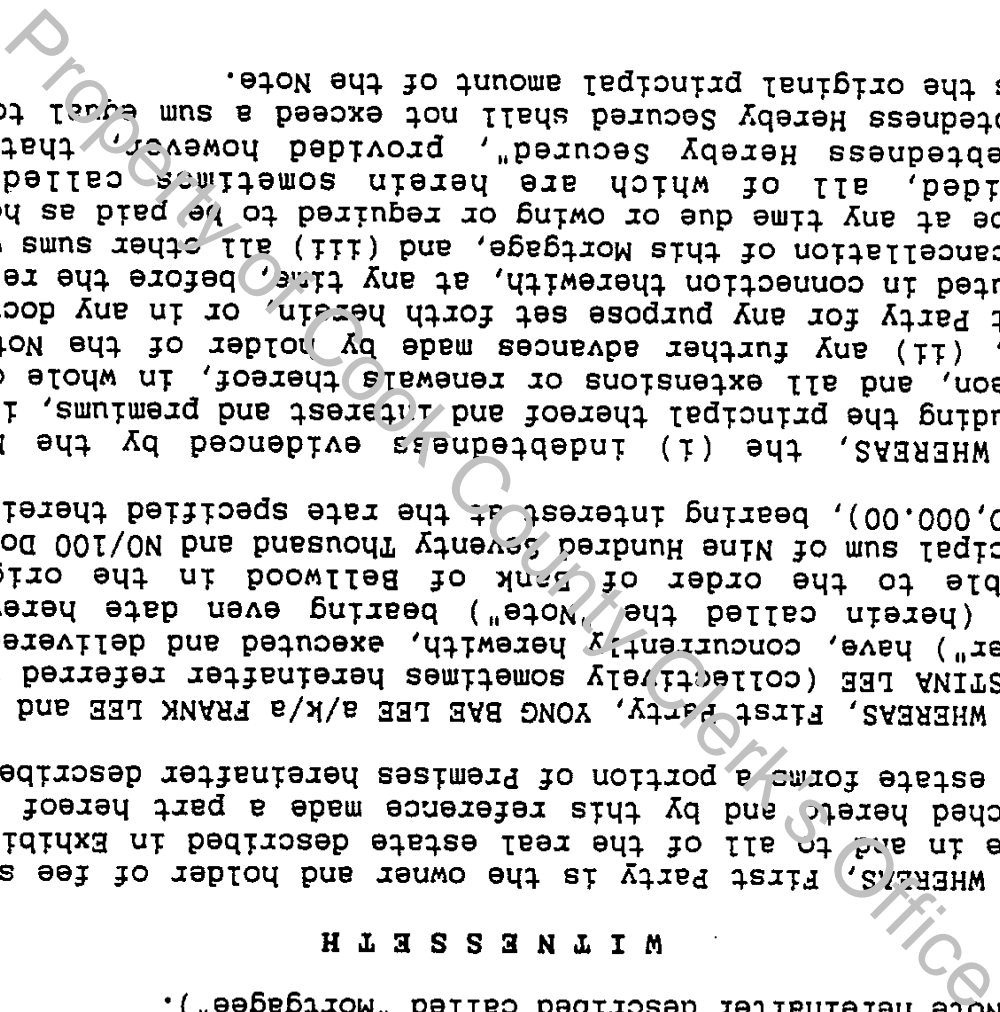

7. Deposits for Tax and Insurance Deposits: For the purpose of providing funds with which to pay the general taxes and special assessments levied against the said premises, First Party shall make monthly deposits with the holder of the Note on the day of every month, in an amount estimated by the holder of the Note to be equal to 1/12th of the general real estate taxes and special assessments last levied against the same premises, and equal to 1/12th of the bills last received for premiums in insurance covering the Premises.
