Cook County, Illinois, to wit:

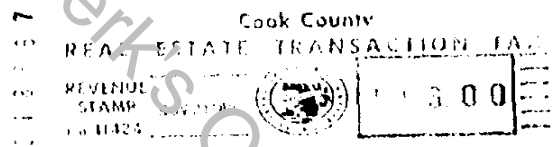
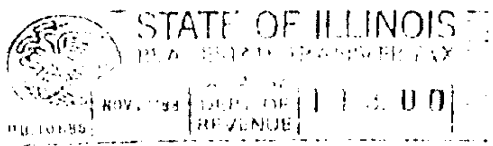

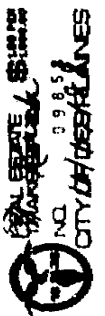
