You and each of you are hereby notified that the Village of Flossmoor, County of Cook, which provides fire protection services is about to annex the territory hereinafter described pursuant to the provisions of Article 7, Division 1 of the Illinois Municipal Code (Chapter 24 Illinois Revised Statutes) and that such annexation will take place not less than ten (10) days after the service of this notice upon you to wit on October 17, 1988. Said Real Estate is described as follows:

That part of the West Half ($\frac{1}{2}$) of the Southwest Quarter ($\frac{1}{4}$) of Section 11, Township 35 North, Range 13 East of the Third Principal Meridian, bounded and described as follows: Beginning at the Southwest Corner of the Southwest Quarter ($\frac{1}{4}$) of Said Section 11, Thence North on the West Line of the Southwest Quarter ($\frac{1}{4}$) of said Section 11 a distance of 1684.83 feet, more or less, to a Point on the North Line of the South 20 Acres of the North Half ($\frac{1}{2}$) of said Southwest Quarter ($\frac{1}{4}$) of Section 11, thence East on the last described line to a point 111 feet West of the East line of the West Half ($\frac{1}{2}$) of said Southwest Quarter ($\frac{1}{4}$) of Section 11 to the North line of Lot 1 in Wilken's Subdivision of the East Half ($\frac{1}{2}$) of the Southeast Quarter ($\frac{1}{4}$) of the Southwest Quarter ($\frac{1}{4}$) of the Southwest Quarter ($\frac{1}{4}$) of said Section 11, Thence West on the last described line of the Northwest corner of Lot 1 in said Wilken's Subdivision thence South on the West line of Lot 1, in said Wilken's Subdivision, to the Southwest Corner of Lot 1, in said Wilken's Subdivision also being the Southeast Corner of Lot 2, in said Wilken's Subdivision, thence West on the South line of Lot 2, in said Wilken's Subdivision, to the Southwest Corner of Lot 2, in said Wilken's Subdivision, also being the Northwest Corner of Lot 3, in said Wilken's Subdivision, thence south on the West line of Lot 3, in said Wilken's Subdivision, and said line extended South to the South Line of the Southwest Quarter ($\frac{1}{4}$) of said Section 11, thence West on the South Line of said Southwest Quarter ($\frac{1}{4}$) of Section 11 a distance of 996.30 feet, more or less to the point of beginning, all in Cook County, Illinois. Said territory containing 44.15 Acres, more or less, and being surrounded by the Village of Flossmoor, another municipality and a Forest Preserve District.

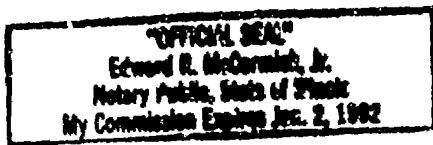
