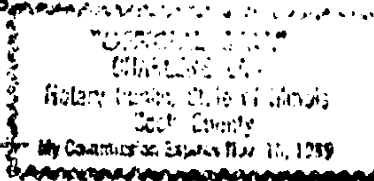

EXHIBIT A
