ASSIGNMENT AND ASSUMPTION OF OPERATING AGREEMENT

WHEREAS, Assignor is the owner and/or lessee of certain real property more particularly described in attached Exhibit A (the "Predises"); and

WHEREAS, the Premises are subject to and/or Assignor is a party to those certain documents listed in attached Exhibit X, as the same may have been modified, amended or supplemented, directly or indirectly, by any document which in any manner affects the Premises or the shopping center of which the Premises are a part, recorded or unrecorded (collectively, the "Operating Agreement"); and

WHEREAS, Assignor desires to assign, transfer and convey all of Assignor's right, title and interest in, to and under the Operating Agreement upon the terms hereinafter set forth; and

WHEREAS. Assignee desires to accept the assignment of the Operating Agreement and to assume Assignor's obligations and liabilities thereunder.

NOW, THEREFORE, in consideration of One Dollar (\$1,00) in hand paid by Assigned to Assignor, and for other good and valuable consideration, the mutual receipt and legal sufficiency of which are hereby acknowledged, the parties hereto do hereby agree as follows:

- 1. Effective as of the date set forth above, the Assignor bereby assigns, transfers and conveys to Assignee all of Assignor's right, title and interest in, to and vader the Operating Agreement, to have to hold the same unto Assignee, its successors and assigns, subject to the terms, covenants and conditions contained in the Operating Agreement.
- 2. Assignee hereby accepts the assignment of the Operating Agreement from Assignor and hereby assumes and agrees to observe and perform all the obligations, terms, covenants and conditions thereof to be observed or performed by Assignor thereunder from and after the date set forth above and hereby assumes all liabilities of Assignor to the extent arising out of or relating to the Operating Agreement or to acts or events occurring or conditions existing with respect to the Operating Agreement Whether before or after the date set forth above.
- 3. Assignee acknowledges and agrees that Assignor's rights under the Operating Agreement have been assigned to Assignee on an "as is, where is" hasis, and that no oral or written representations or warranties concerning the Operating Agreement have been made in connection with such assignment.
- 4. This Agreement shall be binding upon, and shall inure to the benefit of, the parties hereto and their respective successors and assigns.
