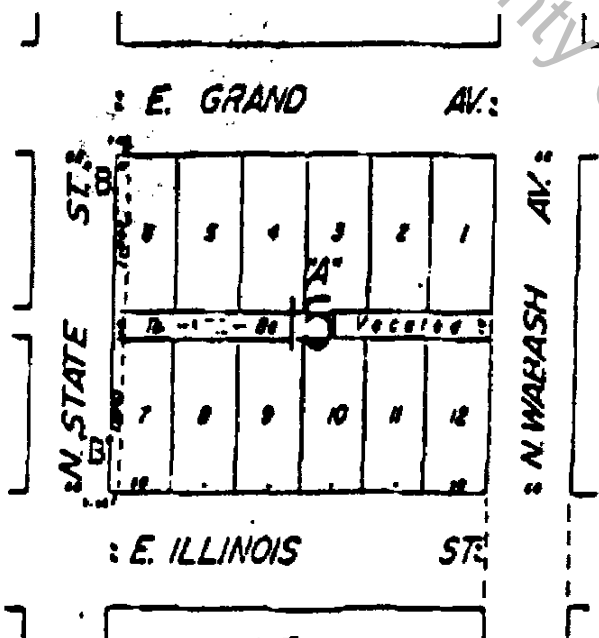
VACATED
