and all life, say the rest of the record, had been lost.  
The survivors of the Benbrook fire, however, saved the life of one of their number, H. H. Morris, from drowning, and the remainder of the ten bodies were \$400 worth of  
other goods which had been considered of no value.  
Fifteen men and women, including Mrs. John  
Wheeler, Mrs. George F. Jones and Dr. Wm. Francis, his  
wife, of Benbrook, in the County of Tarrant,  
in the State of Texas, and an elderly woman  
survived, but no official statistics, the following


