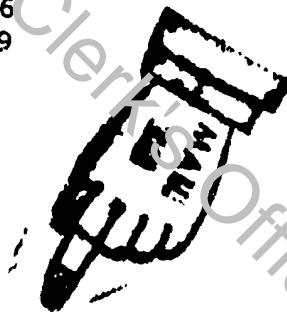

AMENDMENT TO
DECLARATION OF CONDOMINIUM OWNERSHIP
FOR
PARK LANE TOWNHOME CONDOMINIUM

This Amendment is made and entered into by the Bank of Ravenswood, as Trustee under Trust Agreement dated September 15, 1986 and known as Trust No. 25-8030, and not individually ("Trustee").

WITNESS:

Whereas, Trustee submitted a certain parcel of real estate located in the City of Chicago, County of Cook and State of Illinois, as set forth and legally described on the Plat attached hereto as Exhibit 1 and incorporated herein by this reference, to the provisions of the Condominium Property Act of the State of Illinois in the Declaration of Condominium Ownership for Park Lane Townhome Condominium, filed for record with the Recorder of Deeds of Cook County, Illinois on June 5, 1988 as Document No. 88248725 ("Declaration"); and

Whereas, pursuant to Paragraph C of Article XIV of Declaration, Trustee reserved the right to record an amendment to Declaration or any Exhibits to Declaration for the purpose of correcting such Exhibits and Trustee was granted the power to make or consent to such amendments on behalf of each Unit Owner; and

Whereas, a new Plat of Survey has been prepared which more accurately describes the Property, as such term is defined in Declaration; and

Whereas, Trustee wishes to amend Declaration and Exhibits to Declaration by supplementing the existing Plat of Survey, attached as Exhibit A to Declaration, with the new Plat of Survey referred to above.

Now, therefore, the Bank of Ravenswood as Trustee, for the purposes set forth above, hereby amends Declaration as follows:

1. The recitations set forth above are incorporated herein and made a part hereof.
2. The Plat of Survey attached as Exhibit A to Declaration is hereby supplemented by the Plat of Survey attached hereto as Exhibit 1 which is hereby incorporated into and made a part of said Exhibit A by this reference.
3. In all other respects, Declaration and Exhibits thereto shall remain in full force and effect.
