# AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP FOR PARK LANE TOWNHOME CONDOMINIUM

- 1. The recitations set forth above are incorporated herein and made a part hereof.
- 2. The Plat of Survey attached as Exhibit A to Declaration is hereby supplemented by the Plat of Survey attached hereto as Exhibit 1 which is hereby incorporated into and made a part of said Exhibit A by this reference.
- 3. In all other respects, Declaration and Exhibits thereto shall remain in full force and effect.
