

ARTICLES OF INCORPORATION**UNOFFICIAL COPY****FEES SCHEDULE**

- The filing fee is \$75.00.

ARTICLE THREE

The purpose or purposes for which the corporation is organized are:

To erect, construct, establish, purchase, lease and otherwise acquire and to hold, use, equip, outfit, service, maintain, operate, sell and otherwise dispose of restaurants, delicatessens, fast food restaurants, concessions, franchised outlets and other eating and drinking and establishments of every kind and description and to design and develop food services and to distribute name and generally conduct the business of restaurateurs, preparers, servers and dispensers of food and drink; and to engage in all activities to render all services, and to buy, sell, use, handle and deal in fixtures, machinery, apparatus, equipment, accessories, tools, materials, products and merchandise incidental or related thereto, or of use therein.

To subscribe or cause to be subscribed for, and to purchase or otherwise acquire, hold for investment, sell, assign, transfer, mortgage, pledge or otherwise dispose of the whole or any part of shares of stock, bonds, coupons, mortgages, deeds of trust, debentures and other evidences of indebtedness. None of these purposes shall be deemed to grant the corporation the power of carrying on the business of discounting bills or notes, or in any sense authorize said corporation to carry on the business of banking or the buying and selling of bills of exchange.

To acquire by purchase, exchange, lease or otherwise and to own, hold, use, develop, operate, sell, assign, lease transfer, convey, exchange, mortgage, grant a security interest in or otherwise dispose of or deal in or with, real and personal property of every class and description and rights and privileges therein wheresoever situated.
