

ORDINANCE #269.88

AN ORDINANCE ANNEXING TO THE PARK DISTRICT OF OAK FOREST, COOK COUNTY, ILLINOIS, PROPERTY WITHIN THE CITY OF OAK FOREST NOT PREVIOUSLY IN SAID PARK DISTRICT, WHICH PROPERTY IS DESCRIBED IN THIS ORDINANCE AND LIES WHOLLY WITHIN THE COUNTY OF COOK AND STATE OF ILLINOIS

WHEREAS, Section 3-10 of Chapter 105 of the Illinois Revised Statutes of 1965 provides that a Park District may annex by Ordinance all that territory within a City of Village in which said Park District operates; and

WHEREAS, the Commissioners of the Oak Forest Park
District, Cook County, Illinois, have considered the question
of the annexation of the territory hereinafter described and
have determined that said territory is within the City of Oak
Forest, Cook County, Illinois, and is contiguous to the
territory of the Oak Forest Park District of Cook County, Illinois,
and that the residents thereof currently use the facilities of
said Park District and will in the future use and need
additional facilities in such areas for recreation and park
purposes; and

WHEREAS, it is to the best interests of all of the residents of said Park District and to the best interests of the residents, the voters and owners of the territory hereinafter described to become a part of the Oak Forest Park District.

NOW THEREFORE, BE IT ORDAINED BY THE COMMISSIONERS OF THE OAK FOREST PARK DISTRICT:

Section 1. That the territory hereinafter described, said territory described in this Ordinance, and specifically by reference made a part hereof, which said territory being contiguous to the territory of the Oak Forest Park District of Cook County, Illinois, and not within said Park District, or any other Park District, and within the provisions of Chapter 105, Section 3-10 of the Illinois Revised Statutes of 1965 be and the same is hereby annexed to the Oak Forest Park District, Cook County, Illinois, in accordance with the provisions of said Chapter 105, Section 3-10 of the Revised Statutes of Illinois. The territory hereby annexed, as shown by the shaded areas on the maps hereto attached, which are made a part of this Ordinance, is known and described as follows, to wit:

THE EAST 250 FEET (EXCEPT THE SOUTH 350 FEET THEREOF), OF THE SOUTH 1 OF THE NORTH 1 OF THE EAST 1 OF THE SOUTHWEST 1 OF SECTION 18, TOWNSHIP 36 NORTH, RANGE 13, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

and which said tract of land above described and in the attached description is intended to be all in the territory within the City Limits of the City of Oak Forest not previously included within the Oak Forest Park District.

Section 2. This ordinance shall take effect and be in full force and effert from and after its passage and approval according to law and after fring of a certified copy of this Ordinance and the map attached here'o, in the Office of the Recorder of Deeds and Clerk of the Circuit Court of Cook County, Illinois, as provided by law.
