In addition to the agreement and provision of said Bortgage, the undersigned agree as follows:

- 1. Any provisions of said Hortgage which are inconsistent with the provisions of this Rider are bereby amended or negated to the extent necessary to conform said Mortgage to the provisions of this Rider.
- 2. In order to provide for the payment of taxes and other annual charges upon the property securing the Indebtedness. Nortgagor shall pay to Nortgage on the first day of each worth commencing on the list day of Congress 198%, one twelfth of the estimated annual Real Estate tax bill (based on the then most recent tax bill). Nortgages shall be responsible for applying those funds to the tax bills thereafter due. - It, the failure of Hortgagee to exertice Hortgagee's option for acceration of maturity and/or foreclosure inlimiting any dafault under the Hortgage, or to exercise any other option of mated Hortgagee hereunder. In any one or more instances, or the acceptance by Hortgagee of partial payment hereunder shall constitute a walver of any such default, except as maybe provided by law, nor extend or affect the grace period, if any, but such option shall remain continuously in force. At eleration of maturity once claimed hereunder by Mortgagee may, at the option of Hortgagee, be resclinded by written acknowledgement to that effect by Hortgagee, but the tender and acceptance of partial payment clone shall not in any way effect or resclind such acceleration of maturity, except as provided by law, nor extend or affect the grace period, if nov.
