WHEPEAS, Mortgagor and Stanley N. Washington and Gloria R. ("Co-Borrower" herein) have executed and delivered to Mortgagee a Construction Loan Note of even date delivered in substitution or exchange therefor are hereinafter collectively called the "Note" (a true and correct copy of the Note is attached as Exhibit A hereto and made a part hereof);


WHEREAS, Mortgagee requires that the prompt payment of the Note, including the interes, due in accordance with the terms thereof, and any additional impebtedness accruing to Mortgagee pursuant to the Note, be secured by this Mortgage;

NOW, THEREFORE, Mortgagor, to secure payment of the indebtedness due or to become due paysuant to the Note and this Mortgage, and the performance of the covenants herein and therein contained to be performed kept and observed by Mortgagor, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, does hereby MORTGAGE, GRANT AND CONVEY areo Mortgagee, its successors and assigns, the real estate situated in the City of Chicago, County of Cook and State of Linois, as more particularly described in Pybibit B attached because and made a particularly described in Exhibit B attached hereto and made a part hereof;

TOGETHER with all the improvements now or hereitter erected on the Mortgaged Premises, and all easements, rights, appurtenances all of which shall be-deemed to be and remain a part of the Mortgaged Premises covered by this Mortgage; and all of the foregoing, together with said Mortgaged Premises are hereinafter referred to as the "Mortgaged Premises."

Mortgagor covenants that Mortgagor is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Mortgaged Premises, and that the Mortgaged Premises are unencumbered, except for encumbrances of record. Mortgagor covenants that Mortgagor warrants and will defend generally the title to the Mortgaged Premises against all claims and demands, subject to encumbrances of record.

MORTGAGOR, for itself, its successors and assigns, HEREBY COVENANTS AND, AGREES WITH MORTGAGEE that:

- 1. Payment and Compliance with Note. Mortgagor will duly and punctually pay all principal and interest due on the Note and any late charges required thereunder, and the principal of, and interest on, any Puture Advances (as hereinafter defined) secured by this Mortgage, and will otherwise comply with the terms and conditions of the Note, at the times and in the manner therein provided.
- 2. Prior Mortgages and Deeds of Trust; Charges; Liens. Mortgagor shall perform all of Mortgagor's obligations under any mortgage, deed of trust or other security agreement with a lien which has priority over this Mortgage, including Mortgagor's covenants to make payments when due. Mortgagor shall pay or cause to be paid all taxes, assessments and other charge, and fines ("Impositions" herein) attributable to the Mortgaged Premises which may attain a priority over this Mortgage, and leasehold payments or ground rents, if any. Mortgagor will furnish to Mortgagee a receipt evidencing payment of all applicable Impositions within thirty (30) days of the applicable due date. Mortgagor reserves the right to contest real estate tax payments provided Mortgagor gives written notice to Mortgagee of such contest and tenders to Mortgagee such security for the payment of real estate taxes and protection of the security of this Mortgage as the Mortgagee may require not later than ten (10) business days prior to the due date for the tax.
- 3. <u>Insurance</u>. Mortgagor shall keep the improvements now existing or hereafter erected on the Mortgaged Premises insured against loss or fire, hazards included within the term "extended coverage", and such other hazards as Mortgagee may require and in such amounts and for such periods as Mortgagee may require.

The insurance carrier providing the insurance shall be chosen by Mortgagor subject to approval by Mortgagoe; provided, that such approval shall not be unreasonably withheld. All insurance policies and renewals thereof shall be in a form acceptable to Mortgagee and shall include a standard mortgage clause in favor of and in a form acceptable to Mortgagee, including a provision requiring that the coverage evidenced thereby shall not be terminated or materially modified without thirty (30) days prior written notice to Mortgagee. Mortgagee shall have the right to hold the policies and renewals thereof, subject to the terms of any mortgage, deed of trust or other security agreement with a lien which has priority over this Mortgage.

The delivery to Mortgagee of any policy or policies of insurance required to be maintained hereunder, or any renewals thereof, shall constitute an assignment to Mortgagee of all unearned premiums thereon as further security for the payment of the indebtedness secured hereby. In the event of a foreclosure action or other transfer of title to the Mortgaged Premises in extinguishment of the debt secured hereby, all right, title and interest of Mortgagor in and to any policy or policies of insurance then in force will pass to the purchaser or grantee thereof subject to the terms of any mortgage, deed of trust or other security agreement with a lien which has priority over this Mortgage.

In the event of loss, Mortgagor shall give prompt notice to the insurance carrier and Mortgagee. Mortgagee may make proof of loss if not made promptly by Mortgagor. Subject to the terms of any mortgage, deed of trust or other security

agreement with a lien which has priority over this Mortgage, all proceeds of insurance shall be payabale to Mortgagee and each insurance company with which a claim is filed is authorized to make payment thereof directly to Mortgagee.

If the Mortgaged Premises are abandoned by Mortgagor, or if Mortgagor fails to respond to Mortgagee within 30 days from the date notice is mailed by Mortgagee to Mortgagor that the insurance carrier offers to settle a claim for insurance benefits, Mortgagee is authorized to collect and apply the insurance proceeds at Mortgagee's option either to restoration or repair of the Mortgaged Premises or to the sums secured by this Mortgage.

- Mortgagor will keep and maintenance of Mortgaged Premises. Mortgagor will keep and maintain, or cause to be kept and maintained, the Mortgaged Premises in good order, condition and repair and will make, or cause to be made, as and when necessary, of repairs, renewals and replacements, as and when necessary, of tructural and non-structural, exterior and interior, ordinary and extraordinary. Mortgagor will refrain from and shall not permit or suffer the commission of waste in or about the Mortgaged Premises nor remove, demolish or alter the structural character of any improvements at any time erected on the Mortgaged Premises except in accordance with the provisions of the Construction Loan Agreement hereinafter described and otherwise upon the prior written consent of the Mortgagee.
- 5. Protection of Mortgagen's Security. If Mortgagor fails to perform the covenants and agreements contained in this Mortgage, or if any action or proceeding is commenced which materially affects Mortgagee's interest in the Mortgaged Premises, then Mortgagee, at Mortgagee's option, upon notice to Mortgagor, may make such appearances, disburse such sums, including reasonable attorneys' feet, and take such action as is necessary to protect Mortgagee's interest. If Mortgagee required mortgage insurance as a condition of making the loan secured by this Mortgage, Mortgagor shall pay the premiums required to maintain such insurance in effect until such time as the requirement for such insurance terminates in accordance with Mortgagor's and Mortgagee's written agreement or applicable law.

Any amounts disbursed by Mortgagee pursuant to this paragraph 5. with interest thereon, at the Note 1919, shall become additional indebtedness of Mortgagor secured by this Mortgage. Unless Mortgagor and Mortgagee agree to other terms of payment, such amounts shall be payable upon notice from Mortgagee to Mortgagor requesting payment thereof. Nothing contained in this paragraph 5 shall require Mortgagee to incur any expense or take any action hereunder.

- 6. <u>Inspection</u>. Mortgagee may make or cause to be made reasonable entries upon and inspections of the Mortgaged Premises, provided that Mortgagee shall give Mortgagor notice prior to any such inspection specifying reasonable cause therefor related to Mortgagee's interest in the Mortgaged Premises.
- 7. Compliance With Laws. Mortgagor will promptly comply or cause compliance with, all present and future laws, rules, ordinances, regulations and other requirements of each and every governmental authority having jurisdiction over the Mortgaged Premises with respect to the installation of energy

conservation measures and the use or operation of the Mortgaged Premises or any portion thereof.

- 8. Condemnation. The proceeds of any award or claim for damages, direct or consequential, in connection with any condemnation or other taking of the Mortgaged Premises, or part thereof, or for conveyance in lieu of condemnation, are hereby assigned and shall be paid to Mortgagee, subject to the terms of any mortgage, deed of trust or other security agreement with a lien which has priority over this Mortgage. Mortgager covenants and agrees to give immediate notice to Mortgagee of the actual or threatened commencement of any such proceedings under condemnation or eminent domain affecting all or any part of the Mortgaged Premises.
- 9. Mortgagor Not Released; Forbearance By Mortgagee Not a Waiver. Extension of the time for payment or modification of amortization of the sums secured by this Mortgage granted by Mortgagee to any successor in interest of Mortgagor shall not operate to ralgase, in any manner, the liability of the original Mortgagor and Mortgagor's successors in interest. Mortgagee shall not be required to commence proceedings against such successor of refuse to extend time for payment or otherwise modify amortization of the sums secured by this Mortgage by reason of any demand made by the original Mortgagor and Mortgagor's successors in interest. Any forbearance by Mortgagee in any instance in exercising any right or remedy hereunder, or otherwise afforded by applicable law, shall not be a waiver of or preclude the exercise of any such right or remedy in any other instance.
- 10. Future Advances. It is further covenanted and agreed by the parties hereto that this Mortgage also secures the payment of and includes all future 40 vances as shall be made by Mortgagee or its successors or assigns, to and for the benefit of Mortgagor, to the same extent as if such future advances were made on the date of the execution of this Mortgage ("Future Advances"). The total amount of indebtedness that may be secured by this Mortgage may decrease of increase from time to time and shall include any and all distorsements made by Mortgagee for the payment of taxes, levies or insurance on the Mortgaged Premises with interest on such disbursements at the interest rate under the Note and for attorneys fees and court costs incurred in the collection of any or all if such sums. All future advances shall be wholly optional with Mortgagee and the same shall bear interest at the same rate as specified in the Note unless said interest rate shall be moultied by subsequent agreement.
- 11. Notice. Except for any notice required under applicable law to be given in another manner. (a) any notice to Mortgagor provided for in this Mortgage shall be given by delivering it or by mailing such notice by certified mail addressed to Mortgagor at the Mortgaged Premises Address or at such other address as Mortgagor may designate by notice to Mortgagee as provided herein, and (b) any notice to Mortgagee shall be given by certified mail to Mortgagee's address stated herein or to such other address as Mortgagee may designate by notice to Mortgagor as provided herein. Any notice provided for in this Mortgage shall be deemed to have been given to Mortgagor or Mortgagee when given in the manner designated herein.
- 12. Governing Law: Severability. This Mortgage shall be governed by the laws of the State of Illinois, which laws shall also govern and control the construction, enforceability,

validity and interpretation of this Mortgage. In the event that any provision or clause of this Mortgage or the Note conflicts with applicable law, such conflict shall not affect other provisions of this Mortgage or the Note which can be given effect without the conflicting provision, and to this end the provisions of this Mortgage and the Note are declared to be severable. As used herein, "costs", "expenses" and "attorneys' fees" include all sums to the extent not prohibited by applicable law or limited herein.

- 13. Mortgagor's Copy. Mortgagor shall be furnished a conformed copy of the Note and of the Mortgage at the time of execution or after recordation hereof.
- evidence by the Note and secured by this Mortgage is to be used for the installation of energy conservation measures in certain pulldings, structures and improvements on the real estate here a described in accordance with the provisions of the Construction Loan Agreement between the parties of even date herewith ("Construction Loan Agreement"). Mortgagor covenants that it will perform all the terms, covenants, and conditions of the Construction Loan Agreement to be kept and performed by Mortgagor. All advances and indebtedness arising and accruing under the Construction Loan Agreement from time to time shall be secured hereby to the same extent as though the Construction Loan Agreement were fully incorporated in this Mortgage. Mortgagee, at Mortgagee's option, may require mortgager to execute and deliver to Mortgagee, in a form acceptable to Mortgagee, an assignment of any rights, claims or defenses which Mortgagor may have against parties who supply labor, materials or services in connection with improvements made to the Mortgaged Premises.
- 15. Transfer of the Mortgaged Premises. If Mortgagor sells or transfers all or any part of the Mortgaged Premises or an interest therein, excluding (a) the creation of a lien or encumbrance subordinate to this Mortgage. (b) a transfer by devise, descent, or by operation of law upon the death of a joint tenant, or (c) the grant of any leasehold interest of three years or less not containing an option re purchase, or if the beneficial interest in or power of direction under the titleholding Trust of the Mortgaged Premises is sold, transferred, assigned, pledged, or conveyed, in whole or in part (including without limitation a collateral assignment thereof to any person other than Mortgagee), or if the owner of said beneficial interest is a partnership, any change in, or substitution or withdrawal of fifty percent (50%) of greater interest in the owner, or if the owner is a corporation, any sale, assignment, pledge or other transfer of fifty percent (50%) of the stock of said owner, Mortgagor shall cause to be submitted information required by Mortgagee to evaluate the transferee as if a new loan were being made to the transferee. Mortgagor will continue to be obligated under the Note and this Mortgage unless Mortgagee releases Mortgagor in writing.
- If Mortgagee, on the basis of any information obtained regarding the transferee, determines that Mortgagee's security may be impaired, or believes that there is an unacceptable likelihood of a breach of any covenant or agreement in this Mortgage, or if the required information is not submitted. Mortgagee may declare all of the sums secured by this Mortgage to be immediately due and payable. If Mortgagee exercises such option to accelerate, Mortgagee shall mail Mortgagor notice of acceleration in accordance with paragraph 11 hereof. Such

notice shall provide a period of not less than 30 days from the date the notice is mailed or delivered within which Mortgagor may pay the sums declared due. - 16. Acceleration: Defaults: Remedies. Except as provided in paragraph 15 hereof, upon Mortgagor's breach of any covenant or agreement of Mortgagor in this Mortgage, the Note, the Construction Loan Agreement or the Construction Escrow, including the covenants to pay when due any sums secured by this Mortgage, Mortgagee prior to acceleration shall give notice to Mortgagor as provided in paragraph 11 hereof specifying: (1) the breach: (2) the action required to cure such breach: (3) a date, not less than 10 days from the date the notice is mailed to Mortgagor, by which such breach must be cured; and (4) that failure to cure such breach on or before the date specified in the notice may result in acceleration of the sums secured by this Mortgage, foreclosure by judicial proceeding, and sale of the Mortgaged Premises. The notice shall further inform Mortgagor of the right to reinstate after acceleration and the right to assert in the foreclosure proceeding the nonexistence of a default or any other defense of Mortgagor to acceleration and foreclosure. If the breach is not cured on or before the date specified in the notice, Mortgagee, at Mortgagee's option, may declare all of the sums secured by this Mortgage to be immediately due and payable without further demand and may foreclose this Mortgage by judicial proceeding. Notwithstanding Mortgagee's acceleration of the sums secured by this Mortgage due to Mortgagor's breach, Mortgagor shall have the right to have any proceedings begun by Mortgagee to enforce this Mortgage discontinued at any time prior to entry of a judgment enforcing this Mortgage if: (a) Mortgagor pays Mortgagee all sums which would be then due under this Mortgage and the Note had no acceleration occurred; (b) Mortgagor cures all breaches of any other covenants or agreements of Mortgagor contained in this Mortgage; (c) Mortgagor pays all reasonable expenses incurred by Mortgagee in enforcing the covenants and agreements of Mortgagor contained in this Mortgage, and in enforcing Mortgagee's remedies as provided in paragraph 16 hereof, including, but not limited to, reasonable attorneys' fees; and (d) Mortgagor takes such action as Mortgagee may reasonably require to assure that the lien of this Mortgage, Mortgagee's interest in the Mortgaged Premises and Mortgagor's obligation to pay the sums secured by this Mortgage shall continue unimpaired.
