SPECIAL AMENDMENT
TO THIRD AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP AND
OF BY-LAWS, EASEMENTS, RESTRICTIONS AND
COVENANTS FOR VERITAS CONDOMINIUMS

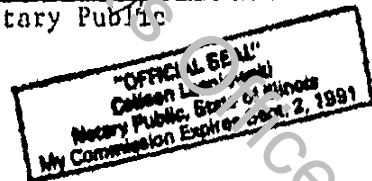
