On or about November 23, 1988 the claimant completed said work to the value of Two Hundred Ninety Eight Thousand and Seven Dollars (\$298,007.00).

That after allowing all credits on account of payments, change orders and otherwise, there is due and owing to the claimant the balance of THIRTY FOUR THOUSAND FIVE HUNDRED NINETY ONE DOLLARS AND FORTY CENTS (\$34,591.40) for which, with interest, the claimant claims a lien on the aforescribed real estate and all improvements thereon.
