NOTICE OF LIEN

NOTICE IS HEREBY GIVEN, that 155 HARBOR DRIVE CONDOMINIUM ASSOCIATION, an Illinois not-for-profit corporation, has and claims a lien pursuant to Chapter 30, Illinois Revised Statutes, Sec.309, against AMERICAN NATIONAL BANK, as Trustee under Trust No. 52806 dated May 20, 1981, upon the property described as follows:
