COLLATERAL ASSIGNMENT OF  
LEASE AND RENTS

THIS ASSIGNMENT, made this 15th day of March, 1988, by NBD Trust Company of Illinois, as Successor Trustee to NBD Highland Park Bank, N.A., formerly known as First National Bank of Highland Park, not individually, but as Trustee under Trust Agreement dated August 19, 1986, and known as Trust Number 4172HP as (Assignor) to NBD Highland Park Bank, N.A., a national banking association, having its principal place of business in Highland Park, Illinois, as Assignee;

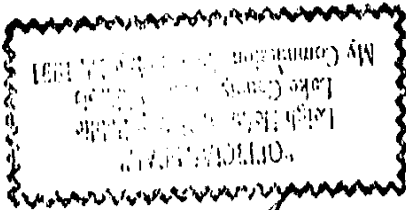

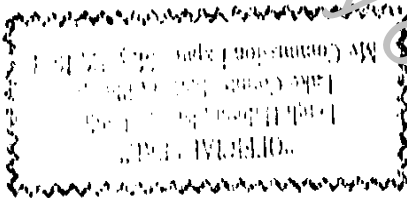
