

Sec. 6321. Lien For Taxes.

If any person liable to pay any tax neglects or refused to e same after designed, the amount (including any in est, additional amount, addition to tax, or assessable pers tegether with any costs that may accrue in addition there shall be a lienthi faiciful this United States upon all propi and rights to presently prosther real or personal, belonging: to such person.

Sec. 6322. Period Of Lien.

Unless another date is specifically fixed by law, the lien sposed by section 6321 shall arise at the time the assessment is made and shall continue until the liability for the amount so assessed (or a judgment against the taxpayer arising out of such Hability) is satisfied or becomes unenforceable by reason of lagos of time.

Sec. 6323. Validity and Priority Against Certain Persons.

(a) Purchaser's, Holders Of Security Inerests, Mechanic's Lienors, And Jud Lien Creditors. - The ilen imposed by section \$321 shall not be valid as against any purchaser, helder of a security interest, mechanic's liener, or judgment lien creditor until notice thereof which meets the requirements of subsection (f) has been flied by the Secretaryst

(i) Real Property - in the case of real property, in one office within the State (or the pospty, or other governmental subdivision), as designated by the laws of such State, in which the property subject to the fion is situated; and

(ii) Personal Property - In the case of personal property, whether tangible or intangible, in one office within the State (or the county, or other governmental subdivision), as designated by the laws of such State, in which the property subject to the ilen is situated;

(B) With Clerk Of District Court - In the office of the clerk of the United States district court for the judicial district in which the property subject to lien is situated, whenever the State has not by law designated one office which meets the requirements of subparagraph (A), or
