ASSIGNMENT OF MORTGAGE

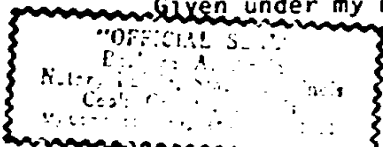

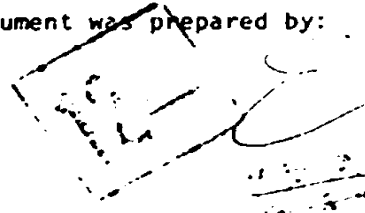
