NOW, THEREFORE, BL IT ORDAINED, by the President and Board of Trustees of the Village of Palatine, acting in the exercise of their home rule power:


SECTION 1: That the following territory:

The North 225 Feet of the South 258 feet of the West 150 feet of the South 495 feet of the East 471.43 feet of the Northeast 1/4 of the Souther 1/4 of Section 16, Township 42 North, Range 10, East of the Third Principal Meridian, (also known as the South 495 feet of the East 471.43 feet of Lot 9 of School Trustee's Subdivision), (Except from said south 495 feet that part, if any, which falls in the North Half of the North Half of the Southeast 1/4 of the Northerst 1/4 of the Southeast 1/4 of Section 16 aforesaid), all in Cook County, Illinois,

Commonly known as 856 West Wood Street

and as shown on the plat of annexation attached hereto and made a part of this ordinance, be and the same is hereby annexed to the Village of Palatine.
