AN ORDINANCE
ANNEXING CERTAIN TERRITORY TO THE VILLAGE OF PALATINE
856 WEST WOOD STREET

The North 225 Feet of the South 498 feet of the West 150 feet of the South 495 feet of the East 471.43 feet of the Northeast 1/4 of the Southeast 1/4 of Section 16, Township 42 North, Range 10, East of the Third Principal Meridian, (also known as the South 495 feet of the East 471.43 feet of Lot 9 of School Trustee's Subdivision), (Except from said south 495 feet that part, if any, which falls in the North Half of the North Half of the Southeast 1/4 of the Northeast 1/4 of the Southeast 1/4 of Section 16 aforesaid), all in Cook County, Illinois,

Commonly known as 856 West Wood Street

and as shown on the plat of annexation attached hereto and made a part of this ordinance, be and the same is hereby annexed to the Village of Palatine.

SECTION 2: That upon passage of this ordinance, a copy hereof, including the plat certified as correct by the Village Clerk, be filed with the Recorder of Deeds of Cook
