That certain Assignment of Leases dated April 18, 1986 made by American National Bank and Trust Company of Chicago, as trustee under Trust Agreement dated April 1, 1974 and known as Trust No. 32868 to and for the benefit of NORTH AMERICAN LIFE ASSURANCE COMPANY and recorded on June 19, 1986 in the office of the Recorder of Deeds of Cook County, Illinois as Document Number 86251394, and filed with the Cook County Registrar of Titles as Document Number 1R3524106.

4. All other documents executed and delivered to Assignor in connection with the transaction in which the documents described in Paragraphs 1, 2 and 3 above were delivered to Assignor.
