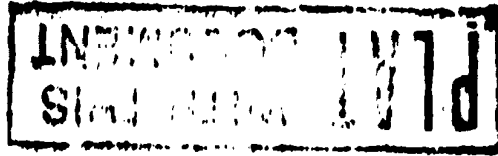

ANNEXATION ORDINANCE NO. 88-0-3

ANNEXING PROPERTIES CURRENTLY WITHIN THE BOUNDARIES OF TINLEY PARK-PARK DISTRICT

WHEREAS, the Illinois Municipal Code provides that a park district may annex areas that are within the municipality in which the district is located and may annex surrounded or nearly surrounded territory of less than eighty (80) acres; and,

WHEREAS, the area set forth herein is mostly within the municipality of Tinley Park and a portion thereof is surrounded by the Tinley Park-Park District and a forest preserve;

NOW, THEREFORE, BE IT ORDAINED by the Tinley Park-Park District as follows:

1. The following legally described area is hereby annexed into the Tinley Park-Park District:

That part of the Northeast $\frac{1}{4}$ of Section 29, Township 36 North, Range 13, East of the Third Principal Meridian, lying South of the North Line of said Section, lying East of the West Line of the Chicago, Rock Island and Pacific Railroad, in Cook County, Illinois.

2. All Ordinances or parts of Ordinances in conflict with this Ordinance are hereby repealed to the extent of such conflict.

3. This Ordinance shall be in full force and effect upon its passage and approval and the acceptance thereof by the Commissioners of the Tinley Park-Park District.
