This agreement dated December 1, 1987 by and between Peterson Bank, hereinafter called Mortgagee; MORIS ESFORMES

hereinafter called Mortgagor; and \_\_\_\_\_, hereinafter called Co-Maker(s):

Witnesseth:

(1) Mortgagee is the holder of a certain Promissory Note Dated December 1, 1986 in the original face amount of Fifty Thousand and 00/100 Dollars (\$ 50,000.00) executed by Mortgagor and Co-Maker(s) and Secured by Mortgage dated December 1, 1986 recorded on December 19, 1986 in the office of the Recorder of Deeds, in the County of Cook, State of Illinois as Document # 86608346 on Real Estate legally described as follows:

(2) The Principal Balance remaining unpaid on the Note is Forty Eight Thousand, Twenty Three and 00/100 Dollars (48,023.00).

(3) Said Principal Balance together with interest is hereby mortgaged to be repayable ON DEMAND, and if demand not be made, then as follows:

- Principal plus accrued interest on \_\_\_\_\_
- Payment of \$ 450.00, including principal and interest beginning January 1, 1988 and continuing monthly/quarterly thereafter, with the balance due on December 1, 1990. Interest shall be computed on the basis of a 365 day year and charged for the actual number of days elapsed.

Interest on the principal balance remaining from time to time unpaid shall be payable prior to maturity at the rate of \_\_\_\_\_ per cent per annum and after maturity at the rate of \_\_\_\_\_ per cent per annum.

Interest on the principal balance remaining from time to time unpaid shall be payable prior to maturity at the prime lending rate of The Wall Street Journal (or its successors) plus 0.0 per cent per annum over the said prime lending rate, and after maturity at the said prime lending rate plus 5.0 per cent per annum over the said prime lending rate, provided, however, that said interest rate in no event shall be less than 0.0 per cent per annum. Any increase or decrease of the rate of interest shall be effective as of the date of said prime lending rate change. All such payments on account of the indebtedness evidenced by this note shall be first applied to interest on the unpaid principal balance and the remainder to the principal.

At the option of the Bank, a prepayment penalty of six (6) months interest will be assessed on all prepayments unless excused by operation of law.

If any part of said indebtedness or interest thereon be not paid as herein provided, or if default in the performance of any other covenant of the mortgage shall continue for ten (10) days, the entire principal sum remaining unpaid together with the then accrued interest shall, without notice, at the option of the holder of said installment Note become due and payable, in the same manner as if said modification had not been granted.

(4) This agreement is supplementary to said Mortgage and said Mortgage shall continue as a good and valid lien on the Real Estate. Neither the Promissory Note nor the Mortgage shall in any way be prejudiced by this agreement. ALL the Provisions of the Promissory Note and Mortgage shall remain in full force and effect and be binding on the Parties hereto except as herein expressly modified.

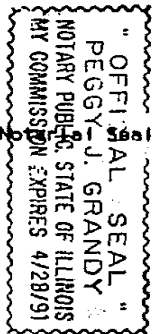
