



La otra parte de la historia es que el 20 de junio de 1940 se firmó en París el Tratado de Múnich, que establecía la cesión de la Ciudadela y la fortaleza de Praga a Alemania. La Ciudadela y la fortaleza de Praga eran las principales fortificaciones de la capital checa. La Ciudadela era una fortificación construida en el siglo XVII por el rey Juan III Sobieski para proteger la ciudad de los ataques otomanos. La fortaleza de Praga era una fortificación construida en el siglo XVIII por el rey José I para proteger la ciudad de los ataques rusos. El Tratado de Múnich establecía que la Ciudadela y la fortaleza de Praga serían cedidas a Alemania en caso de que la Alemania nazi invadiera la Chequia. El Tratado de Múnich fue firmado por el presidente checo Edvard Beneš y el canciller alemán Konrad Adenauer. El Tratado de Múnich fue criticado por muchos países europeos, incluyendo Francia, Gran Bretaña y Estados Unidos, como un acto de traición y un deshonroso acuerdo con el régimen nazi. El Tratado de Múnich fue considerado como un precedente para la posterior invasión de Polonia por parte de Alemania en 1939.
