- If the registered office is changed from one county to another, then the corporation must file with the recorder of fleeds of the new county a certified copy of the articles of incorporation and a certified copy of the statement of change of registered office. Such certified copies may be obtained ONLY from the Secretary of State.
- 5. Any change of registered again, must be by resolution adopted by the board of directors. This statement must then be signed by the President (or vice-president) and by the Secretary (or an assistant secretary).
- 6. The registered agent may report a charge of the registered office of the corporation for which he ONDA CLOUTS or she is registered agent. When the agent points such a change, this statement must be signed by the registered agent.
