ORDINANCE NO. 86-0-040

AN ORDINANCE ANNEXING PROPERTY (VAN OVERMEIR-EIGHNER-PEELER-KALATA)

Be It Ordained by the President and Board of Trustees of the Village of Tinley Park, Cook and Will Counties, Illinois, as follows:

Section 1: That this President and Board of Trustees find as follows:

- (a) A Petition has been filed with the Village Clerk and presented in proper form to the President and Board of Trustees of the Village of Tinley Park, requesting that the territory described in Section 2 of this Ordinance be annexed to the Village of Tipley Park, Cook and Will Counties, Illinois;
- (b) The aftresaid Petition is in proper form under oath, signed by all owners of record of all the land within the territory and by all of the electors residing within or on said territory;
- (c) That there is a highway adjacent to the aforesaid land which is under jurisdiction of Orland Township or its Commissioner of Highways, and therefore notice of the proposed annexation has been served upon and given to the Township Commissioner of Highways and the Board of Town Auditors, Orland Township, Cook County, Illinois, as required by law;
- (d) That the territory described in Section 2 is not located within any fire protection district or public library district, and therefore, no notice need be given to any fire protection district or public library district;
- (e) Such territory described in Section 2 is solely within Cook County and not within the corporate limits of any municipality, but is consiguous to the Village of Tinley Park, Cook and Will Counties, Illinois, a municipality existing under the laws of the State of Illinois.
