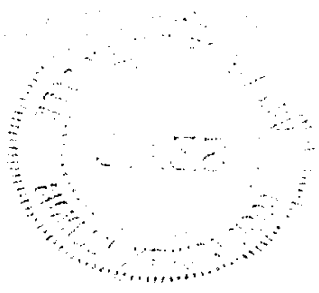

ORDINANCE NO. 86-0-040

AN ORDINANCE ANNEXING PROPERTY
(VAN OVERMEIR-EIGHNER-PEELER-KALATA)

Be It Ordained by the President and Board of Trustees of the Village of Tinley Park, Cook and Will Counties, Illinois, as follows:

Section 1: That this President and Board of Trustees find as follows:

- (a) A Petition has been filed with the Village Clerk and presented in proper form to the President and Board of Trustees of the Village of Tinley Park, requesting that the territory described in Section 2 of this Ordinance be annexed to the Village of Tinley Park, Cook and Will Counties, Illinois;
- (b) The aforesaid Petition is in proper form under oath, signed by all owners of record of all the land within the territory and by all of the electors residing within or on said territory;
- (c) That there is a highway adjacent to the aforesaid land which is under jurisdiction of Orland Township or its Commissioner of Highways, and therefore notice of the proposed annexation has been served upon and given to the Township Commissioner of Highways and the Board of Town Auditors, Orland Township, Cook County, Illinois, as required by law;
- (d) That the territory described in Section 2 is not located within any fire protection district or public library district, and therefore, no notice need be given to any fire protection district or public library district;
- (e) Such territory described in Section 2 is solely within Cook County and not within the corporate limits of any municipality, but is contiguous to the Village of Tinley Park, Cook and Will Counties, Illinois, a municipality existing under the laws of the State of Illinois.

Section 2: That the following described territory be and the same is hereby annexed to the Village of Tinley Park, Cook and Will Counties, Illinois:

Parcel one is legally described as:

Lot 8 in Block 5 in Elmore's Ridgeland Avenue Estates, being a Subdivision of the West $\frac{1}{4}$ of the Northwest $\frac{1}{4}$, and the Northwest $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ all in Section 32, Township 36 North, Range 13, North of the Indian Boundary Line, East of the Third Principal Meridian, in Cook County, Illinois. (Commonly known as 18029 S. Ridgeland.)

- (b) a plat of the land included in this annexation, as required by law, said plat to be annexed to the aforesaid certified copy of this Ordinance.

Section 4: That this Ordinance shall be in full force and effect from and after its passage and approval as required by law.

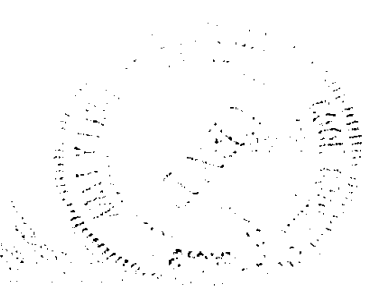
