

Sec. 6321. Lien For Taxes.

Sec. 8523. Validity and Priority Against Certain Persons.

(a) Directorer's, Holders Of Security Interest Mechanic's Lienors, And Judgment Lien Graditors. — The Sen Imposed by section 921 shall not be write as against any purchaser, holder of a yearsty learnest, mechanic's lienor, or judgment then creditor until notice thereof which meets the requirements of subsection (f) has been tited by the Secretary.
