THIS INDENTURE, made December 22, 1987 between M.J. MEADOW, INC. (herein referred to as ("Mortgagor") and BANK OF BUFFALO GROVE, an Illinois banking corporation (herein referred to as "Mortgagee") witnesseth:

THAT WHEREAS, Mortgagor, has concurrently herewith executed a Mortgage Note (herein referred to as the "Note") bearing even date herewith in the principal sum One Hundred Sixty Eight Thousand and 00/100 DOLLARS (\$168,000.00) made payable to Mortgagee and delivered, in and which Note, Mortgagor promises to pay on or before December 22, 1988 the said principal sum with interest as set forth in the Note.

All such payments on account of the indebtedness evidenced by said note to be first applied to interest on the unpaid principal balance and the remainder to principal. All of said principal and interest being make payable at the principal office of the Mortgagee in Buffalo Grove, Illinois.

In addition, the Mortgagor covenants with the Mortgagee as follows:

1.
