MEMORANDUM OF JUDGMENT FOR RECORDING PURPOSES

IT IS HEREBY STIPULATED between the parties that a Judgment for Dissolution of Marriage in Case Number 87 D 7953 was entered December 24, 1987, by the Circuit Court of Cook County, Illinois. Said Judgment provided in part:

"Husband shall purchase wife's interest in the marital residence located at 1481 Clifford, Elk Grove Village, Illinois, (legally described on Exhibit A) for the sum of \$45,000.00 payable \$25,000.00 within 30 days from the entry of the Judgment for Dissolution of Marriage and \$20,000.00 within ten (10) years of date of Judgment for Dissolution of Marriage or upon sale of home, whichever is sooner. Said \$20,000.00 lien shall not bear interest. Wife shall quitclaim by deed her interest to husband upon entry of a Judgment for Dissolution of Marriage and sums owing to wife by husband shall constitute a lien in favor of wife against the property commonly known as 1481 Clifford, Elk Grove Village, Illinois, legally described as per Exhibit A. A memorandum reflecting wife's lien rights in accordance with this paragraph shall be executed by the parties and recorded against the premise to perfect wife's lien."

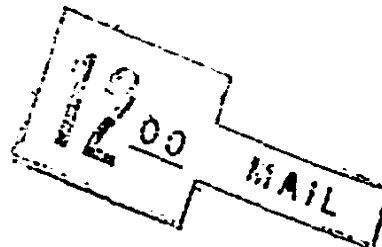

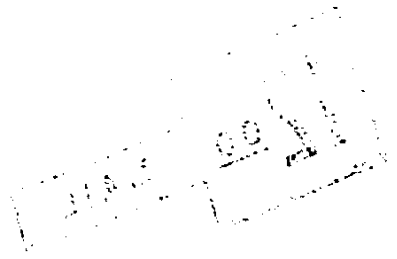
