DR. ADRIANO UDANI and FELISA UDANI, First Parties, and Palos Bank and Trust Company  
as Trustee.

Unit No. 2528 as delineated on survey of certain lots in the Plat of Lake Front Plaza, a Subdivision of a parcel of land lying in accretions to fractional Section 10, Township 39 North, Range 14 East of the Third Principal Meridian, according to the Plat thereof recorded April 30, 1962, as Document No. 18461961, conveyed by Deed from Illinois Central Railroad Company to American National Bank and Trust Company of Chicago, as Trustee under Trust No. 17460, recorded May 7, 1962, as Document No. 18467558, and also supplemental Deed thereto recorded December 23, 1964 as Document No. 19341545, which survey is attached as Exhibit 'A' to Declaration of Condominium made by American National Bank and Trust Company of Chicago, as Trustee under Trust Agreement dated April 9, 1962 and known as Trust No. 17460, recorded in the office of the Recorder of Cook County, Illinois as Document No. 22453315, together with an undivided .09510 percent interest in the property described in said Declaration of Condominium aforesaid (excluding the units defined and set forth in the Declaration of Condominium and Survey) in Cook County, Illinois.

Grantors also hereby grant to Trustee, its successors and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of said property set forth in Declaration made by American National Bank and Trust Company of Chicago, as Trustee under Trust Agreement dated April 9, 1962 and known as Trust No. 17460, recorded in the Office of the Recorder of Cook County, Illinois, as Document No. 22453315.

The trust is subject to all rights, easements, restrictions, conditions, covenants and reservations contained in said Declaration the same as though the provisions of said Declaration were recited and stipulated at length herein.

Paragraphs succeeding Paragraph "A" of said Trust Deed are hereby amended to refer only to the designated condominium unit, together with easements, entitlements and interest in the common element, and any of the items specified in said paragraphs owned by First Party or its Trust beneficiaries.
