NOTES TWENT THE PROPERTY OF THE PARTY OF THE

1. The registered office may, but need not be the same as the principal office of the corporation. However, the registered office and the office address of the registered agent must be the same.

2. The registered office must include a street or road address, a post office box number alone is not acceptable.


3. A corporation cannot act as its own registered agent.
