ORDINANCE NO. 2829

AN ORDINANCE TO ANNEX CERTAIN TERRITORY TO
THE VILLAGE OF GLENVIEW, COOK COUNTY, ILLINOIS

WHEREAS, the corporate authorities of the Village of Glenview, have determined that annexation of certain territory in Cook County, Illinois, hereinafter described, is in the public interest and in the best interests of the Village of Glenview, and will promote the public health, safety and welfare of the Village and its residents; and

WHEREAS, the corporate authorities of the Village of Glenview, a home rule municipality, find that the following described territory is unincorporated territory containing less than 60 acres and is wholly bounded by the Village of Glenview.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Glenview, Cook County, Illinois, that

Section 1: The unincorporated territory, containing less than 60 acres and wholly bounded by the Village of Glenview, legally described as follows:

That part of the Northwest 1/4 of Section 25, Township 42 North, Range 12, East of the Third Principal Meridian, described as follows: Beginning at the Northwest corner of the East 1/2 of Lot 14 in Block 3 in the Fourth addition to Glen Oak Acres according to the plat thereof recorded October 22, 1926 as Document No. 944027; thence Easterly along the North line of Lots 14 to 24, inclusive, in said Block 3 and along said line extended Easterly and along the North line of Lots 13 to 23, inclusive, in Block 4 in the Fourth addition to Glen Oak Acres, aforesaid, to a point of intersection with the West line of the East 36.00 feet of Lot 23 in said Block 4; thence Southerly along said last described West line and along the Southerly extension thereof to a point of intersection with the South line of Queens Lane, said South line being also the North line of Lot 2 in Block 1 of the Fifth addition to Glen Oak Acres according to the plat thereof recorded October 22, 1926 as Torrens Document No. 325018; thence Easterly along said last described North line to a point of intersection with the East line of the West 20.00 feet of said Lot 2; thence Southerly along said last described East line to a point of intersection with the South line of said Lot 2; thence Westerly along the South line of Lots 2 to 12, inclusive, in said Block 1 and along said line extended Westerly and along the South line of Lots 1 to 9, inclusive, in Block 2 in the Fifth addition to Glen Oak Acres, aforesaid, to a point of intersection with the West line of the East 1/2 of Lot 9 in said Block 2, thence Northerly along said last described West line and along the Northerly extension thereof to a point of intersection with the South line of Block 3 in the Fourth addition to Glen Oak Acres, aforesaid, said line being also the North line of Queens Lane; thence Westerly along said South line of Block 3 to a point of intersection with the West line of the East 1/2 of Lot 14 in said Block 3; thence Northerly along said last

described West line to the place of beginning, in Cook County, Illinois.

be and the same is hereby annexed to the Village of Glenview, Cook County, Illinois, pursuant to the provisions of Section 7-1-13 of the Illinois Municipal Code.

Section 2: The Clerk of the Village of Glenview is hereby authorized and directed to record with the Recorder of Deeds of Cook County, Illinois, a certified copy of this ordinance, together with an accurate map of the territory annexed, attached hereto and made a part hereof and a document of annexation shall be filed with the County Clerk and the County Election Authority.

Section 3: This ordinance shall take full effect upon its passage and approval according to law.
