OPDINANCE NO. 2829

AN ORPINANCE TO ANNEX CERTAIN TERRITORY TO THE VILLAGE OF GLENVIEW, COOK COUNTY, ILLINOIS

WHEREAS, the corporate authorities of the Village of Glenview, have determined that annexation of certain territory in Cook County, Illinois, hereinafter described, is in the public interest and in the best interests of the Village of Glenview, and will promote the public health, safety and welfare of the Village and its residents; and

WHEREAS, the corporate authorities of the Village of Glenview, e home rule municipality, find that the following described tectitory is unincorporated territory containing less than 60 acres and is wholly bounded by the Village of Glenview.

NOW, THEREFOR! BE IT CRDAINED by the President and Board of Trustees of the village of Gleaview, Cook County, Illinois, that

Section 1: The unincorporated territory, containing less than 60 acres and who 13 bounded by the Village of Glenview, legally described as follows:
